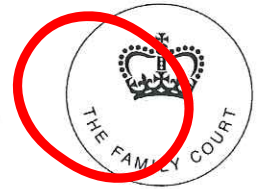
- (1) The second and third respondents' applications for leave to oppose pursuant to section 47(5) of the Adoption and Children Act 2002 are refused,

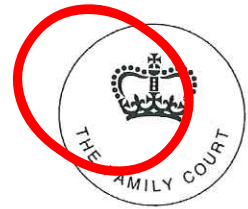
